On Friday, the Department of Homeland Security issued a draft proposal to the Office of Management and Budget that would allow foreign students to work in the U.S. after graduating if they got an offer of employment (see chart) with a salary of as little as \$13,500 per year. The proposal has received no formal public reaction, although supporters say it has much of the momentum needed to survive. Secretary of Homeland Security Michael Chertoff and Secretary of Labor Elaine L. Chao are said to be supportive. A spokesman for the labor secretary said Sunday he could not comment on the proposal. A spokesman for the Homeland Security Secretary said he could not comment on the proposal until the formal announcement. But supporters say the proposal, which is expected to be made final soon, is a long-awaited attempt to address a simmering political controversy over foreign student recruitment. At the moment, the rules under the existing Optional Practical Training (OPT) program, which is not a formal part of the H-1B visa program, limit the number of foreign students in the U.S. to two years. After that, they must go back to their country of origin. Although the two years of work is usually supposed to be in the college or university setting, the OPT rules include a provision, known as the 40-hour law, that allows foreign students who graduate from American schools to continue working

on their master's or doctorate, as long as the work relates to their studies. The Bush administration's proposal is also designed to address an issue that has long plagued the H-1B program: The record number of applications made this past year -- more than 400,000 -- which is more than double last year's total. The rules make the final decision about foreign students in the U.S. up to the employers. The proposal is the latest action in the immigration debate since last week, when the administration lifted a ban on assault rifles and assault weapons, allowing gun owners to buy them. The administration also made new rules to allow foreign graduates of U.S
