We requested the Fort Worth Bar to file a brief, and the State filed a response. We have determined that the writ is appropriate under Texas Rule of Appellate Procedure 52.8(a) and under the facts of this case. See Tex. R. App. P. 52.8(a), 52.10. We, therefore, will issue a peremptory writ of mandamus instructing the district court to withdraw its order on the plea to the jurisdiction and to order discovery or to conduct a hearing and to rule on the State's plea to the jurisdiction. See Tex. R. App. P. 52.10(a). Further, the district court shall, within twenty days of the date of this opinion, issue an order scheduling the district court for trial on the State's plea to the jurisdiction or conduct a hearing on the plea to the jurisdiction.
